


This request was made in an Letter from the Client dated 26 November 2002 and reference Testing to BS 7320:1990. It is emphasized that assessments were not made against the other clauses of the Specification.

This Report only relates to the actual samples which have been tested and assessed. The results obtained do not necessarily relate to samples from the production line and in no way imply the performance or quality of the continuing production.

10 off 1.8 Litre Sharps Containers plus Lids
10 off 3 Litre Sharps Containers plus Lids
10 off 5 Litre Sharps Containers plus Lids
10 off 10 Litre Sharps Containers plus Lids

SUMMARY OF RESULTS

The 1.8 Litre, 3 Litre and 5 Litre Sharps containers failed to meet the requirements of clauses 7 and 8 of the specification, but met the requirements of those other clauses, or parts thereof, against which assessments were made.

The 10 Litre Sharps container failed to meet the requirements of clause 8 of the specification, but met the requirements of those other clauses, or parts thereof, against which assessments were made.

The potential variability in, both the items tested and the method of measurement used, means that for measurements close to a specified limit, the level of confidence in a compliance statement may or may not be reduced.
